BOTTOM PAINTING

Includes Haul Out, Block, Pressure Wash, standard prep, paint, labor and related materials. Subject to bottom inspection. Any additional prep will be billed at standard rate. Includes selected quality bottom paints from SeaHawk. Aluminum boats may be higher. Heavy displacement or extra wide beam may be additional. **Upgrades are available at additional cost**

New bottom paint application: \$210/ft for fiberglass \$260/ft for aluminum up to 40'

PLEASE NOTE:

All Boat Owner's (Do-It-Yourselfer's) and Contractors must read and sign the Environmental Agreement (BMP'S - *Best Management Practices*), be Authorized to work in the yard, and provide proof of insurance before proceeding with work.

Sanding of bottom paint is **prohibited**. All other sanding is subject to approval by the **Yard Manager** prior to work beginning and requires the use of a vacuum sander, if approved.

Stand adjustments by Owners are NOT ALLOWED and subject to a fine of \$500 per stand
LaConner Maritime crew will move stands at owners request.

Staying on boats while in the yard is NOT ALLOWED.

Subcontractors:

Proof of Liability Insurance Required. Must read and sign BMPs, and be authorized to work in the yard. Contractor fees may apply.

All invoices are due and payable before the vessel is launched.

LaConner Maritime prefers cash, cashier checks, personal checks, debit cards or wire transfers.
A 2.6% service fee will be added for credit cards.
